LMGC Reimbursement Policy

For all GCA hosted meetings, including the GCA Annual Meeting, GCA Zone XI Annual Meeting, GCA Shirley Meneice Horticulture Conference, and GCA Conservation/NAL Meeting, the full registration fee, inclusive of meals and event expenses, is paid by the LMGC for officers, delegate and committee chairs. - 3. When writing a letter/email or telephoning a legislative contact, include your address, as your contact will usually want to reply.
- 4. Use your own words or the suggestions in the Position Papers and Legislative Updates, giving the reasons why you are for or against the legislation. Identify the legislation by popular name or bill number.

While my mother might not recognize some of the tools we are now using, I am happy to report the business of the garden club continues...in a new way!

Programs

Program Chair Dustin MacGregor put together a great year of programs, concentrating on different types of gardens. Lisa Philander, Director of the University of MN College of Biological Services, started off July by describing the new conservatory that will bring plants of the world to Minnesota. Kate Sammons, a doctoral student at the University of MN and one of our scholarship winners as well as a GCA scholarship winner, shared practical ways to include beneficial herbs in our gardens. Theresa Mieseler, owner of Shady Acres shared some of her favorite herbs and flowers. August brought tours of several hidden gardens in our midst. The Donation Garden in Long Lake managed by Janie Delaney, LMGC Administrative Support, is a 10,000 square foot vegetable garden that donated over 2,700 pounds of fresh produce last year. The Giving Garden at St. Therese of Deephaven also managed by volunteers, produced 4,700 pounds of fresh produce which they donate to needy families through ICA food shelves. Our September Conservation meeting was held at a new site. French Regional Park Visitor Center. Respected author and chef. Beth Dooley discussed her new book as well as her thoughts on farm to table cooking and Minnesota's role as the breadbasket to the world. Adam Kostanecki, University of MN Plant and Microbial major and our 2nd scholarship winner, highlighted his involvement with the West Bank Community Garden. Jenny and John Thull, LMGC Horticulture Commendation winners for their vineyards in 2018, shared their vast knowledge with their second love, all things gourds and pumpkins and squash. Sharing their homemade treats and handing out a few of the 300 varieties they grow was a great bonanza for the members who attended the October meeting at the Arboretum. Arts and Flowers head designer, Adam Bladu, put us all in the holiday mood with his spectacular flower arrangements. Unfortunately, we had to cancel our April meeting which would have several CSA farmers giving an overview of organic farming in Minnesota. In a first, our May Horticulture meeting was held via Zoom. Julie Weisenhorn, University of Minnesota Horticulture Extension Educator, shared the results of her recent studies on Flowers for Pollinators which showed that pollinators like natives and annuals in red, yellow, blue, purple and white. Due to unprecedented circumstances, the annual meeting shifts to a "pick-up" boxed lunch at Woodhill Barn followed by a Zoom meeting on-line.

The LMGC Board did a fantastic job this year, especially when a worldwide pandemic derailed plans for our spring and summer. Here are a just few of their accomplishments:

- Mimi Rae, Corresponding Secretary wrote personal notes when needed, and with a great deal of patience did an outstanding job of creating/updating our Yearbook.
- **Tori Gagne**, Awards selected a well deserving group of club awards which you can see in the Awards section of the Yearbook.

- Barbara Burgum & Kate Bryant, Bulb Sale added LMGC notecards to the mix of gift giving bulbs and raised \$2,200 for future scholarship winners.
- Heather Haeg, Communications submitted several articles to the GCA Bulletin.



2011 The Lake Minnetonka Garden Club held a GCA Flower Show, "What a State We're In," July 12-14 at the Minnesota Landscape Arboretum. Pam Ulvestad chaired the event.

Establishment of The LMGC Scholarship to offer educational scholarships to Minnesota students who have selected horticulture and its related fields as their focus. Two students received \$1,000 this year.

- **2012** The Club's historian, Ethel Smith, is in the process of updating the history and Archives of LMGC from 1927 to present. These materials when up-dated will be presented in a book to GCA for their 100th Anniversary. Betsy Massie is assisting with technical know-how and Jane Noland and Ronnie Winsor are providing much needed help.
- **2014** In addition to the volunteer service at the Depot Garden, members filled 3 hour shifts at the Wayzata Historical Society once a month. Horticulture and Visiting Gardens chair Kathleen Wanner organized a club

trip to Philadelphia famous flower show, featuring extra excursions to gardens and art collections nearby.

Co-sponsored two programs with the St. Paul Garden Club one with Cole Burrell, garden designer and garden travel expert, and a photography workshop and lecture featuring Betty Goodwin.

2015 The Bee Fund spearheaded by Associate Member Ronnie Winsor challenged the club to raise \$50,000 for the Minnesota Landscape Arboretum. Vice President Kathy Coward not only took on the challenge but has surpassed our goal and with 100% participation from the members.

At The Lake Minnetonka Garden Club Annual June meeting, a check for \$60,000 was presented to the Minnesota Landscape Arboretum for the Pollinators at the Tashjian Bee and Pollinator Center Garden.

- **2015-16** Depot Garden in Wayzata redesigned as a Pollinator Garden.
- **2016** The Lake Minnetonka Garden Club hosted the GCA Annual Meeting "Journey to the Heartland", May 19-22. Co-chaired by Betsy Massie (LMGC) and Colleen Fitzpatrick (St. Paul GC).

A plaque recognizing the support of The Lake Minnetonka Garden Club was installed at the Pollinator Garden of the new Tashjian Bee and Pollinator Discovery Center. The Club was also listed on a donor wall at the site which opened in September 2016.

2017 Visiting Gardens was moved from Horticulture and merged with Garden History and Design into a new Lake Minnetonka Garden Club Committee that celebrates our gardens by documenting, sharing, and visiting them.

Betsy Massie (LMGC) and Colleen Fitzpatrick (SPGC) received the first ever Zone XI Appreciation Award for their inspiring leadership at the 2016 GCA Annual Meeting.

2018 Barbara Burgum's documented garden with photos were accepted into the archives of the American Gardens at the Smithsonian Institute. This was the Club's first documented garden since 2003.

The Lake Minnetonka Garden Club celebrated its 60th anniversary as founding partner of the Minnesota Landscape Arboretum, including serving as the Honorary Organization for the Arboretum's Diamond Gala.

The LMGC launched a new website that is more fluid and user-friendly and will provide more interest to our membership and our community.

Historical Highlights cont.

2019 The Founding the Future: Young Gardeners Initiative Capital Campaign set a \$30,000 goal. The club raised \$56,000 for the Flowers for Pollinators program where, in partnership with MN Landscape Arboretum, Master Gardeners will educate elementary students throughout MN on pollinator health and habitat.

Conducted an online survey to membership covering programs, fundraising, interests and suggestions.

2020 The year of Covid-19 and "social distancing" included a virtual flower show, a drive by garden tour, a medicinal herbs workshop, a Zoom presentation about annuals and pollinators, The Great Garlic Mustard Pull done at home and a Zoom annual meeting.

Gerald and Kay Erickson's marsh and garden restoration project is being documented and archived at the the Smithsonian Institute.

Endowment Fund Chair was added as a newly appointed position.

BYLAWS OF THE LAKE MINNETONKA GARDEN CLUB

ARTICLE I – NAME AND PURPOSE

The name of this Corporation shall be The Lake Minnetonka Garden Club.

The purpose of The Lake Minnetonka Garden Club is to stimulate the knowledge and love of gardening, horticulture, the art of flower arranging, garden history and design and photography, to restore, improve and protect the quality of the environment through action in the field of conservation, and to share the advantages of association by means of educational meetings and civic projects.

ARTICLE II – BOARD OF DIRECTORS

The Board of Directors shall be composed of the Executive Committee and Standing Committee Chairs.

ARTICLE III – EXECUTIVE COMMITTEE AND OFFICERS

The Executive Committee shall consist of the:

President Vice President Recording Secretary

Corresponding Secretary Treasurer

All members of the Executive Committee shall serve as the Officers of the Corporation.

ARTICLE IV – MEMBERSHIP

There shall be five classifications of membership in the Lake Minnetonka Garden Club (the "Club"): Active, Associate, Non-Resident Active, Non-Resident, and Honorary.

Membership Classes:

- A. Active Members
 - 1. To be eligible, the candidate must possess a garden in the Lake Minnetonka area and have a genuine interest in one or more of the Club's purposes.
 - 2. A candidate may also become a member of the Club if:
 - a. the candidate is already a member of a Garden Club of America ("GCA") garden club and moves into the Minneapolis area from out of town; and / or
 - b. no suitable GCA- affiliated garden club exists in the candidate's residential area.
- B. Associate Members
 - 1. To be eligible, the candidate shall have been an active member who has completed ten or more years of distinguished service in the Club. It is an honor and privilege to belong to this class of membership.
 - 2. A candidate may also become an associate member of the Club if:
 - a. the candidate is already a member of a GCA garden club, has completed ten or more years of distinguished service, and moves into the Minneapolis area from out of town; and / or
 - b. no suitable GCA- affiliated garden club exists in the candidate's residential area.
- C. Non-Resident Active Members

Have established residency outside of Minnesota, but still have a residence in the Lake Minnetonka area and have a garden.

D. Non-Resident Members

The candidate shall have been an Active or Associate Member of the Club who has moved out of state and thus no longer can fulfill membership requirements.

E. Honorary Members

Persons who have rendered outstanding service to the Club over a period of years may be selected by the Board for honorary membership. Honorary members will be entitled to the privileges of the Club excluding voting, holding office, representing the Club as a delegate to Zone or Annual Meetings and proposing or endorsing candidates for membership.

ARTICLE V – DUES

The Board of Directors, with the approval of the membership, shall fix the amount of and levy membership dues and assessments. Dues may be changed by a majority vote of a membership quorum.

ARTICLE VI – NOMINATIONS AND VACANCIES

The Nominating Committee shall propose and present a single slate of Officer and Chair candidates, as well as their Assistants, to the Board of Directors for approval. The Nominating Chair shall present the approved slate to the membership for a vote at the annual meeting. Nominations may be made from the floor. If this occurs, voting must be done by ballot. The Nominating Committee shall fill Board vacancies, with approval by the Board of Directors.

ARTICLE VII – PRINCIPAL OFFICE

The principal office for the transactions of the Corporation and the records thereof shall be kept at such place in the County of Hennepin, State of Minnesota, as may be fixed from time to time by the Board of Directors.

ARTICLE VIII – FISCAL YEAR

The fiscal year of the Corporation shall begin July 1 and end June 30 of the following year.

ARTICLE IX – CONTRACTS, CHECKS, BANK ACCOUNTS

- A. All contracts and pledges of support shall be recommended by the Board of Directors and approved by the membership.
- B. Checks or other orders for payment of money issued shall be signed by such person or persons as shall be determined by the Board of Directors.
- C. All funds shall be deposited to the credit of the Corporation in such bank trust companies, or other depositories as the Board of Directors may designate and shall be under the supervision of the Treasurer.

ARTICLE X – PARLIAMENTARY AUTHORITY

Robert's Rules of Order Revised shall be the parliamentary authority of this Corporation in all matters not specified in the bylaws.

ARTICLE XI – REVISIONS AND AMENDMENTS

These bylaws, policies and rules of procedure may be revised or amended at any annual or regular meeting by a majority vote of a membership quorum provided the proposed revision(s) or amendment(s) has been approved by a majority vote of the Board of Directors, and members have been notified in advance of the meeting at which the voting is to take place.

ARTICLE XII – INDEMNIFICATION OF THE BOARD OF DIRECTORS

Indemnification is governed by the Minnesota Non-Profit Corporation Act of 1990 Section 317A Section 290.05 of Subdivision 2.

ARTICLE XIII – TAX EXEMPT INFORMATION

The Lake Minnetonka Garden Club qualifies as an organization exempt from Federal Income Tax under Section 501(c) (3). The Corporation's Federal Income Tax number is 237-01-0551. The Lake Minnetonka Garden Club was incorporated October 1968 as a non-profit Corporation Minnesota Statute Chapters 317. As of January 1, 1991, The Lake Minnetonka Garden Club is governed by Minnesota Statutes Chapter 317A.

POLICIES OF THE LAKE MINNETONKA GARDEN CLUB

I. MEMBERSHIP

- A. The number of active members of The Lake Minnetonka Garden Club (the "Club") shall be limited to seventy (70).
- B. The number of associate members of the Club shall be limited to sixty (60).

II. DUTIES AND PRIVILEGES OF MEMBERS

- A. Active Members are required to:
 - 1. Pay annual dues.
 - 2. Attend at least four meetings per year.
 - 3. Serve as an officer, board member, committee chair or committee member when asked.
 - 4. Participate in all fundraising activities.
 - 5. Participate in all club projects, including workshops, work in the Depot Garden, flower shows, and the Partner for Plants garlic mustard pull.
 - 6. Participate in meetings by being a hostess or offering your home.
 - 7. Attend all orientation meetings and workshops for new members your first year.
 - 8. Have a garden or love to garden.
 - 9. Work one Saturday morning at the Wayzata Library Historical Society once every few years.

- B. Active Members have the following privileges:
 - 1. Membership in The Garden Club of America (the "GCA"), which includes receiving its communications and "Visiting Gardens" opportunities.
 - 2. Participation in educational programs related to the mission of the Club.
 - 3. Opportunities to be a delegate to an Annual or Zone meeting of the GCA.
 - 4. Opportunities to propose or second a candidate for membership.
 - 5. Receiving the minutes of regular meetings and the Club Yearbook.
- C. Associate Members are required to:
 - 1. Pay dues.
 - 2. Support fundraising activities.
 - 3. Serve as a host or co-host at meetings.
 - 4. Vote at meetings.
- D. Associate Members have the following privileges:
 - 1. All the privileges of the Active Members excluding:
 - a) holding office in either the Club or the GCA and;
 - b) being a delegate to a GCA Annual or Zone meeting of GCA.
- E. Non-Resident Members are required to:
 - 1. Pay dues.
- F. Non-Resident Members have the following privileges:
 - All the privileges of the Active and Associate Members excluding:
 a) voting;
 - b) holding office in either the Club or the GCA;
 - c) representing the Club as a delegate to a GCA Annual or Zone meeting; and
 - d) proposing or endorsing candidates for membership in the Club.
- G. Non-Resident Active Members have all the privileges of Active Members:
 - 1. Except may not represent the Club as a delegate to a GCA annual or zone meeting.
 - 2. A Non-Resident Active Member must still have a residence in the Lake Minnetonka area as well as have a garden.
 - 3. She may hold a board position and vote.
 - 4. Members who decide to go Non-Resident will be given the option of being Non-Resident Active.
- H. Honorary Members are required to:
 - 1. Act as a consultant when asked to do so.
- I. Honorary Members have the following privileges:
 - 1. All the privileges as the Non-Resident Members.
 - 2. Honorary Members do not pay dues.

III. ELECTION OF MEMBERS

- A. Membership Proposal Procedure:
 - 1. A proposed candidate's name and qualifications shall be submitted to the Membership Chair by April 15. A second letter of endorsement shall be submitted to the Membership Chair by April 15.
 - 2. A member may propose only one candidate and second only one candidate each year.
 - 3. A member of the Board of Directors may not propose a candidate but may second only one candidate each year.
 - 4. A member may not propose or second a candidate of the member's immediate family.

- B. Membership Election Procedure:
 - 1. The number of membership vacancies shall be determined by the Board of Directors.
 - 2. A candidate shall be voted to membership, by ballot, by a majority vote of the Board of Directors at its April meeting.
 - 3. Upon election, the candidate shall receive a written invitation to membership and a memorandum with the requirements of membership.
 - 4. Elected candidates shall be introduced to the Club membership at the Annual Meeting.
- C. Changes in Membership Classification and Resignations:
 - 1. Applications to transfer membership classification shall be made in writing to the Corresponding Secretary by April 15. The Board of Directors shall vote upon the request.
 - 2. A member wishing to resign shall write a letter of resignation to the Corresponding Secretary by April 15.
 - 3. The Board of Directors shall be empowered to terminate a membership on thirty (30) days notice for non-payment of dues or assessments and/or poor attendance at meetings.

IV. MEETINGS

- A. Regular Meeting.
 - 1. There shall be at least six meetings each year.
- B. Annual Meeting.
 - 1. The Annual Meeting shall be held in June.
 - a) At the Annual Meeting, the members shall elect new Officers and new Standing Committee Chairs comprising a new Board of Directors from a slate proposed by the Nominating Committee and approved by the current Board of Directors.
- C. Board of Directors Meetings.
 - 1. Board of Directors meetings shall be held, if practicable, prior to a regular membership meeting.
- D. Executive Committee Meetings.
 - 1. The Executive Committee shall meet at the request of the President.
 - 2. The Executive Committee shall have all the powers of the Board of Directors between Board meetings. Any action taken by the Executive Committee must be approved by majority vote of the Board at its next meeting.
- E. Special Meetings.
 - 1. Special meetings of the membership may be called at any time by the President, or, in the absence of the President, by the Vice President.
 - 2. Special meetings of the Board of Directors may be called at any time by the President, or in the absence of the President, by the Vice President.
- F. Notice of Meetings.
 - 1. Not less than five, or more than thirty (30) days' notice shall be given for regular membership and Board of Directors meetings.
- G. Annual and Zone meetings of the GCA.
 - 1. The GCA allows two delegates to attend its Annual and Zone meetings. One delegate shall be the President, or an alternate chosen by the President to serve in the capacity of the President. The second delegate should be a Club member who has made an outstanding contribution to the club. The appointment is made by the President subject to Board approval.
 - 2. The Club may pay the registration fee and traveling expenses for two delegates.

H. Quorum

- 1. The presence of a majority of the members of the Board of Directors shall constitute a quorum at Board meetings.
- 2. Thirty-five (35) voting members shall constitute a quorum at membership meetings and/or for purposes of conducting Club business.
- 3. A quorum must be present to transact club business at any meeting of the membership and at any Board of Directors' meeting, and a majority vote shall rule.

RULES OF PROCEDURE

I. DUTIES OF THE EXECUTIVE COMMITTEE

- A. The President shall:
 - 1. Act as the Chief Executive Officer of the Corporation, have general authority over the business of the Corporation and be charged with the duty of its proper management.
 - 2. Preside at all meetings of the Board of Directors, the Executive Committee, and regular meetings.
 - 3. Keep in a notebook and electronically in a drop box all legal records, corporate records, bylaws, policies, amendments and rules of procedure.
 - 4. Appoint in accordance with Board approval:
 - a) Two members to the Membership, Nominating & Bylaws Committee to prepare a slate of candidates and review as deemed necessary any by laws, policies, procedures or Standing Committee job descriptions;
 - b. A Membership, Nominating, & Bylaws Chair to act during the second year of the Presidency;
 - c. An Associate Member Liaison to the Board and;
 - d. Ad hoc Committee Chairs.
 - 5. Present to the Membership the GCA Founders Fund finalists and conduct a vote.
 - 6. Oversee the nomination applications and presentations of the Club's GCA awards.
 - 7. Attend GCA Annual Meetings.
 - 8. Attend Zone Meetings and President's Council Meetings when such meetings are held in the Zone.
 - Invite the Zone Chairman and Vice Chairman to attend one Club meeting during her term of office. The Zone Director, Zone Representatives and National Officers living in Zone XI may also be invited.
 - 10. Prepare an annual report for GCA Headquarters and the Yearbook.
 - 11. Oversee the review of the Club financial records at the request of the Board.
- B. The Vice President shall:
 - 1. Act for or have power of the President in the absence of, or in the case of disability of, the President.
 - 2. Arrange and be responsible for an orientation program for new members.
 - 3. Chair the Grants and Contributions Committee.
 - 4. Appoint and oversee Ways and Means Committee.
 - 5. Chair the Project Research Committee.
 - 6. Attend Board of Directors meetings and regular member meetings.
 - 7. Prepare and submit an annual report.
 - 8. Review the attendance records for the monthly membership meetings at the end of the year.

- C. The Recording Secretary shall:
 - 1. Record minutes of all regular, Board and Executive Committee meetings.
 - 2. Take attendance at Board meetings.
 - 3. Get a copy of the Program Chair's record of attendance at regular membership meetings (annually).
 - 4. Provide all Board of Directors meeting minutes to Board Members.
 - 5. Provide all regular membership meeting minutes to members electronically in a timely manner prior to the next meeting date.
 - 6. Keep a notebook of each month's Board minutes and regular membership meeting minutes.
 - 7. Send the Zone XI Chairman a copy of regular meeting minutes each month.
 - 8. Deliver hard copies of board and meeting minutes to the Historian at year-end to be filed in the Archives.
 - 9. Prepare an annual report.
- D. The Corresponding Secretary shall:
 - 1. Serve as the Club Administrator as defined by the GCA job description.
 - 2. Maintain and keep current the Club's membership records, including keeping the Club's demographic information current on the GCA database.
 - 3. Verify with the Treasurer that the GCA website roster has been updated by June 1 for the determination of Club GCA dues and insurance fees for the next fiscal year.
 - 4. Attend to all Club correspondence and keep all Club stationery.
 - 5. Send a written invitation to membership and a copy of membership requirements to each elected candidate and inform the sponsors of each candidate of their candidate's invitation and acceptance.
 - 6. Notify requesting members of the approval of requested changes in membership status.
 - 7. Compose and send sympathy notes on behalf of the Club.
 - 8. Send a letter of regret to members who have resigned.
 - 9. Prepare an annual report.
 - 10. Oversee the annual Club Yearbook publication and distribution.
- F. The Treasurer shall:
 - 1. Oversee the Club Bookkeeper's financial responsibilities including managing funds, paying bills, signing checks, preparing a monthly Profit & Loss Statement and Balance Sheet detailing all fund balances.
 - Collect member annual dues and income from all Club activities. Record all transactions and deposit funds in the Club's bank account. Review monthly bank statements.
 - 3. Make a financial report at Board, regular and Annual Meetings.
 - 4. Prepare a budget with the President, Vice President and Assistant Treasurer.
 - 5. Review the year-end tax returns in coordination with an accounting firm, to be signed by the President and Treasurer or as requested by the Board of Directors.
 - 6. Attend Monthly Board meetings or, if unavailable, send the Assistant Treasurer.
 - 7. Serve as a mentor to the Assistant Treasurer.
 - 8. Prepare an Annual Report.
 - 9. Participate as a member on the Grants and Contributions Committee.
 - 10. Distribute Conflict of Interest Forms to all new Board members for signature and maintain file of forms.
 - 11. Determine payment to GCA for annual dues and instruct Bookkeeper to forward payment by September 1.
 - 12. Be familiar with GCA Fiscal Policy as it concerns Insurance Coverage. Obtain Certificate of Liability Insurance from GCA Finance Assistant. Coordinate the submittal of the Insurance Activity Report to GCA with the Program Chair by September 1.

II. TERM OF OFFICE OF THE EXECUTIVE COMMITTEE

- A. The term of office shall be two years.
- B. The President, Vice President, and Recording Secretary shall be elected in evennumbered years. The Treasurer and Corresponding Secretary shall be elected in odd-numbered years.

- B. The following committees shall have appointed non-voting Chairs:

 - 3. Membership, Nominating & Bylaws
 - 4. Ways and Means
- C. An Assistant Chair shall become the Chair at the end of the term of office or as otherwise noted in the job descriptions.
- D. Chairs are encouraged to form committees in order to develop membership participation in activities.
- E. The duties of the Chair are subject to change by action of the Board of Directors.
