The Lake Minnetonka Garden Club thrived through a wonderful year in 2023-2024 with enriching programs, marvelous gatherings, and stronger friendships. At every opportunity, our LMGC members dug in together and gardened, learned from enriching programs, and created beautiful floral arrangements and photographs. This year, we built new, long lasting LMGC commitments that will enrich our club and community far into the future.

In 2023-2024, our Lake Minnetonka Garden Club programs were focused around the theme, “Rediscovering our Roots.” **Heather Heag** built an amazing curriculum that included presentations about the connections between personal and global health, the healthful practice of forest bathing, and the seasonal routine of planting and harvesting flowers and foods. All of the programs were terrific.

Our member meetings were complemented with a wonderful array of special events and visiting gardens throughout the summer and autumn seasons. **Andrea Bassett** and **Harriet Chute** arranged several wonderful garden tours including a puffball mushroom class in **Kitty Petit**’s woods that included swapping recipes. In October, **Mitzi Magid** hosted an amazing evening with UMN Raptor Center that taught us all about raptors, the challenges they face, and how important raptors are for a healthy ecosystem.

Our photography committee is more active and amazing than ever! **Anne Kaufman** plans inspiring and learning-packed photography meetings focusing on a topic, such as still lifes or photo series. Our LMGC photographers are terrific, placing and winning photography shows across the country. Bravo!

Our LMGC members are very committed to conservation issues. **Larey Ann Swanson** led our conservation team with monthly newsletter articles about conservation efforts that we can put into practice. Becky Rom spoke at our November LMGC meeting about the work to preserve the pristine waters of the BWCA and Superior-Quetico watershed. LMGC nominated Becky Rom for the GCA’s Zone XI Conservation Commendation and Becky was recognized for her crucial work. LMGC’s **Ellen Phelps** worked with GCA clubs across the country to have April proclaimed Native Plant Month by state governors, including by Minnesota’s Governor Walz. The Proclamation declares that native plants are crucial for a healthy ecosystem.

Our club continues our dedication to education by supporting graduate and undergraduate students with a LMGC scholarship to study in fields related to horticulture, botany, and landscape design. The LMGC scholarship fund was established in 2011 and to date we have granted 20 student scholarships in Minnesota colleges and universities. In 2023, **Dustin Macgregor** and **Jean Dovenberg** led the LMGC scholarship process, awarding two student scholarships. Alyssa Headley was awarded to continue her studies in horticulture and Kiersten Wille was awarded to study environmental sciences. These scholarships were funded through the hard work of **Shelly McGinnis** who chaired the Ways & Means fundraising activities.

Through the summer of 2023, LMGC members **Mimi Rae, Lockie Markeson, Mary Meyer, Heidi Heiland,** and **Bobbie Dressen** worked with the team from the City of Wayzata to plan for a beautiful and healthy Depot Garden in the years ahead. Our Historian **Meredith Howell** coordinated our Club's work with the Wayzata History Society and researched important LMGC information for our 100th birthday celebration. **Melissa Johnson**, the chair of the 100th Anniversary team, began planning for a fun and meaningful centennial anniversary celebration for LMGC.

In 2023, our club established the Lake Minnetonka Centennial Endowment Fund to support education in horticulture, conservation, and botany and to foster and fund community projects in the Lake Minnetonka area. Our leadership team of **Betsy Massie, Bobbie Dressen, Mitzi Magid, Pam Ulvestad, Margene Fox** and **Kate Bryant** led the launch of the LMGC Centennial Endowment Fund and it was met with great support, enthusiasm, and success!

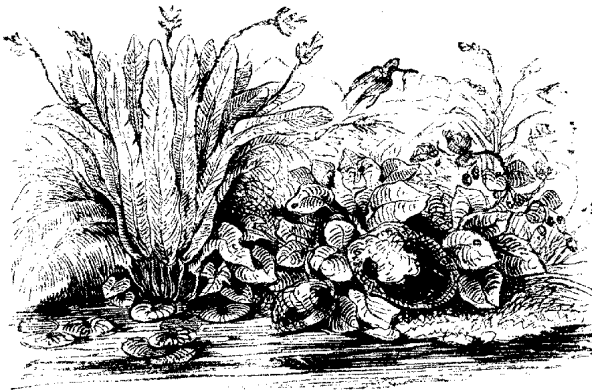

## **BYLAWS OF THE LAKE MINNETONKA GARDEN CLUB**

### **ARTICLE I – NAME AND PURPOSE**

The name of this Corporation shall be The Lake Minnetonka Garden Club.

The purpose of The Lake Minnetonka Garden Club is to stimulate the knowledge and love of gardening, horticulture, the art of flower arranging, garden history and design and photography, to restore, improve and protect the quality of the environment through action in the field of conservation, and to share the advantages of association by means of educational meetings and civic projects.

### **ARTICLE II – BOARD OF DIRECTORS**

The Board of Directors shall be composed of the Executive Committee and Standing Committee Chairs.

### **ARTICLE III – EXECUTIVE COMMITTEE AND OFFICERS**

The Executive Committee shall consist of the:

President      Vice President      Recording Secretary  
Corresponding Secretary      Treasurer

All members of the Executive Committee shall serve as the Officers of the Corporation.

## **ARTICLE IV – MEMBERSHIP**

There shall be four classifications of membership in the Lake Minnetonka Garden Club (the “Club”): Active, Associate, Secondary, and Honorary regardless of residency.

Membership Classes:

### **A. Active Members**

1. To be eligible, the candidate must possess a garden in the Lake Minnetonka area and have a genuine interest in one or more of the Club’s purposes.
2. A candidate may also become a member of the Club if:
  - a. the candidate is already a member of a Garden Club of America (“GCA”) garden club and moves into the Minneapolis area from out of town; and / or
  - b. no suitable GCA- affiliated garden club exists in the candidate’s residential area.

### **B. Associate Members**

1. To be eligible, the candidate shall have been an active member who has completed ten or more years of distinguished service in the Club. It is an honor and privilege to belong to this class of membership.
2. A candidate may also become an associate member of the Club if:
  - a. the candidate is already a member of a GCA garden club, has completed ten or more years of distinguished service, and moves into the Minneapolis area from out of town; and / or
  - b. no suitable GCA- affiliated garden club exists in the candidate’s residential area.

### **C. Secondary Members**

A GCA member whose primary club is not LMGC.

### **D. Honorary Members**

Persons who have rendered outstanding service to the Club over a period of years may be selected by the Board for honorary membership. Honorary members will be entitled to the privileges of the Club excluding: voting, holding office, representing the Club as a delegate to Zone or Annual Meetings, proposing or endorsing candidates for membership and dues.

## **ARTICLE V – DUES**

The Board of Directors, with the approval of the membership, shall fix the amount of and levy membership dues and assessments. Dues may be changed by a majority vote of a membership quorum.

## **ARTICLE VI – NOMINATIONS AND VACANCIES**

The Nominating Committee shall propose and present a single slate of Officer and Chair candidates, as well as their Assistants, to the Board of Directors for approval. The Nominating Chair shall present the approved slate to the membership for a vote at the annual meeting. Nominations may be made from the floor. If this occurs, voting must be done by ballot. The Nominating Committee shall fill Board vacancies, with approval by the Board of Directors.

## **ARTICLE VII – PRINCIPAL OFFICE**

The principal office for the transactions of the Corporation and the records thereof shall be kept at such place in the County of Hennepin, State of Minnesota, as may be fixed from time to time by the Board of Directors.

## **ARTICLE VIII – FISCAL YEAR**

The fiscal year of the Corporation shall begin July 1 and end June 30 of the following year.

## **ARTICLE IX – CONTRACTS, CHECKS, BANK ACCOUNTS**

- A. All contracts and pledges of support shall be recommended by the Board of Directors and approved by the membership.
- B. Checks or other orders for payment of money issued shall be signed by such person or persons as shall be determined by the Board of Directors.
- C. All funds shall be deposited to the credit of the Corporation in such bank trust companies, or other depositories as the Board of Directors may designate and shall be under the supervision of the Treasurer.

## **ARTICLE X – PARLIAMENTARY AUTHORITY**

Robert’s Rules of Order Revised shall be the parliamentary authority of this Corporation in all matters not specified in the bylaws.

## **ARTICLE XI – REVISIONS AND AMENDMENTS**

These bylaws, policies and rules of procedure may be revised or amended at any annual or regular meeting by a majority vote of a membership quorum provided the proposed revision(s) or amendment(s) has been approved by a majority vote of the Board of Directors, and members have been notified in advance of the meeting at which the voting is to take place.

## **ARTICLE XII – INDEMNIFICATION OF THE BOARD OF DIRECTORS**

Indemnification is governed by the Minnesota Statutes, Chapter 317A Non-Profit Corporations.

## **ARTICLE XIII – TAX EXEMPT INFORMATION**

The Lake Minnetonka Garden Club qualifies as an organization exempt from Federal Income Tax under Section 501(c) (3). The Corporation’s Federal Income Tax number is 23-701-0551. The Lake Minnetonka Garden Club was incorporated October 1968 as a Non-Profit Corporation Minnesota Statutes, Chapter 317A.

## **POLICIES OF THE LAKE MINNETONKA GARDEN CLUB**

### **I. MEMBERSHIP**

- A. The number of active members of The Lake Minnetonka Garden Club (the “Club”) shall be limited to seventy (70).
- B. The number of associate members of the Club shall be limited to sixty (60).

### **II. DUTIES AND PRIVILEGES OF MEMBERS**

- A. Active Members regardless of residency are required to:
  - 1. Pay annual dues.
  - 2. Attend at least four meetings per year.
  - 3. Serve as an officer, board member, committee chair or committee member when asked.
  - 4. Participate in all fundraising activities.
  - 5. Participate in all club projects, including workshops, work in the Depot Garden, flower shows, and the Partner for Plants garlic mustard pull.
  - 6. Participate in meetings by being a hostess or offering your home.
  - 7. Attend all orientation meetings and workshops for new members your first year.
  - 8. Have a garden or love to garden.
  - 9. Work one Saturday morning at the Wayzata Library Historical Society once every few years.



- B. Active Members regardless of residency have the following privileges:
  1. Membership in The Garden Club of America (the "GCA"), which includes receiving its communications and "Visiting Gardens" opportunities.
  2. Participation in educational programs related to the mission of the Club.
  3. Opportunities to be a delegate to an Annual or Zone meeting of the GCA.
  4. Opportunities to propose or second a candidate for membership.
  5. Receiving the minutes of regular meetings and the Club Yearbook.
- C. Associate Members and Secondary Club Members regardless of residency are required to:
  1. Pay dues.
  2. Support fundraising activities.
  3. Serve as a host or co-host at meetings.
  4. Vote at meetings.
- D. Associate Members and Secondary Club Members regardless of residency have the following privileges:
  1. All the privileges of the Active Members excluding:
    - a) holding office in either the Club or the GCA and;
    - b) being a delegate to a GCA Annual or Zone meeting of GCA.
- E. Honorary Members are required to:
  1. Act as a consultant when asked to do so.
- F. Honorary Members have the following privileges:
  1. All the privileges of an Associate Member or Secondary Member.
  2. Honorary Members do not pay dues.

### **III. ELECTION OF MEMBERS**

- A. Membership Proposal Procedure:
  1. A proposed candidate's name and qualifications shall be submitted to the Membership Chair by April 15. A second letter of endorsement shall be submitted to the Membership Chair by April 15.
  2. A member may propose only one candidate and second only one candidate each year.
  3. A member of the Board of Directors may not propose a candidate but may second only one candidate each year.
  4. A member may not propose or second a candidate of the member's immediate family.
- B. Membership Election Procedure:
  1. The number of membership vacancies shall be determined by the Board of Directors.
  2. A candidate shall be voted to membership, by ballot, by a majority vote of the Board of Directors at its April meeting.
  3. Upon election, the candidate shall receive a written invitation to membership and a memorandum with the requirements of membership.
  4. Elected candidates shall be introduced to the Club membership at the Annual Meeting.
- C. Changes in Membership Classification and Resignations:
  1. Applications to transfer membership classification shall be made in writing to the Corresponding Secretary by April 15. The Board of Directors shall vote upon the request.
  2. A member wishing to resign shall write a letter of resignation to the Corresponding Secretary by April 15.
  3. The Board of Directors shall be empowered to terminate a membership on thirty (30) days notice for non-payment of dues or assessments and/or poor attendance at meetings.

## IV. MEETINGS

- A. Regular Meeting.
  - 1. There shall be at least six meetings each year.
- B. Annual Meeting.
  - 1. The Annual Meeting shall be held in June.
    - a) At the Annual Meeting, the members shall elect new Officers and new Standing Committee Chairs comprising a new Board of Directors from a slate proposed by the Nominating Committee and approved by the current Board of Directors.
- C. Board of Directors Meetings.
  - 1. Board of Directors meetings shall be held, if practicable, prior to a regular membership meeting.
- D. Executive Committee Meetings.
  - 1. The Executive Committee shall meet at the request of the President.
  - 2. The Executive Committee shall have all the powers of the Board of Directors between Board meetings. Any action taken by the Executive Committee must be approved by majority vote of the Board at its next meeting.
- E. Special Meetings.
  - 1. Special meetings of the membership may be called at any time by the President, or, in the absence of the President, by the Vice President.
  - 2. Special meetings of the Board of Directors may be called at any time by the President, or in the absence of the President, by the Vice President.
- F. Notice of Meetings.
  - 1. Not less than five, or more than thirty (30) days' notice shall be given for regular membership and Board of Directors meetings.
- G. Annual and Zone meetings of the GCA.
  - 1. The GCA may allow two delegates to attend its Annual and Zone meetings. One delegate shall be the President, or an alternate chosen by the President to serve in the capacity of the President. The second delegate should be a Club member who has made an outstanding contribution to the club. The appointment is made by the President subject to Board approval.
  - 2. The Club may pay the registration fee according to the current Travel & Reimbursement policy.
- H. Quorum
  - 1. The presence of a majority of the members of the Board of Directors shall constitute a quorum at Board meetings.
  - 2. Thirty-five (35) voting members shall constitute a quorum at membership meetings and/or for purposes of conducting Club business.
  - 3. A quorum must be present to transact club business at any meeting of the membership and at any Board of Directors' meeting, and a majority vote shall rule.

# **RULES OF PROCEDURE**

## **I. DUTIES OF THE EXECUTIVE COMMITTEE**

### **A. The President shall:**

1. Act as the Chief Executive Officer of the Corporation, have general authority over the business of the Corporation and be charged with the duty of its proper management.
2. Preside at all meetings of the Board of Directors, the Executive Committee, and regular meetings.
3. Keep in a notebook and electronically in a drop box all legal records, corporate records, bylaws, policies, amendments and rules of procedure.
4. Appoint in accordance with Board approval:
  - a) Two members to the Membership, Nominating & Bylaws Committee to prepare a slate of candidates and review as deemed necessary any by laws, policies, procedures or Standing Committee job descriptions;
  - b) An Associate Member Liaison to the Board and;
  - c) Ad hoc Committee Chairs.
5. Present to the Membership the GCA Founders Fund finalists and conduct a vote.
6. Oversee the nomination applications and presentations of the Club's GCA awards.
7. Attend GCA Annual Meetings.
8. Attend Zone Meetings and President's Council Meetings when such meetings are held in the Zone.
9. Invite the Zone Chairman and Vice Chairman to attend one Club meeting during her term of office. The Zone Director, Zone Representatives and National Officers living in Zone XI may also be invited.
10. Prepare an annual report for GCA Headquarters and the Yearbook.
11. Oversee the review of the Club financial records at the request of the Board.

### **B. The Vice President shall:**

1. Act for or have power of the President in the absence of, or in the case of disability of, the President.
2. Arrange and be responsible for an orientation program for new members.
3. Chair the Grants and Contributions Committee.
4. Appoint and oversee Ways and Means Committee.
5. Chair the Project Research Committee.
6. Attend Board of Directors meetings and regular member meetings.
7. Prepare and submit an annual report.
8. Review the attendance records for the monthly membership meetings at the end of the year.

### **C. The Recording Secretary shall:**

1. Record minutes of all regular, Board and Executive Committee meetings.
2. Take attendance at Board meetings.
3. Get a copy of the Program Chair's record of attendance at regular membership meetings (annually).
4. Provide all Board of Directors meeting minutes to Board Members.
5. Provide all regular membership meeting minutes to members electronically in a timely manner prior to the next meeting date.
6. Keep a notebook of each month's Board minutes and regular membership meeting minutes.
7. Send the Zone XI Chairman a copy of regular meeting minutes each month.
8. Deliver hard copies of board and meeting minutes to the Historian at year-end to be filed in the Archives.
9. Prepare an annual report.

- D. The Corresponding Secretary shall:
  - 1. Serve as the Club Administrator as defined by the GCA job description.
  - 2. Maintain and keep current the Club's membership records, including keeping the Club's demographic information current on the GCA database.
  - 3. Verify with the Treasurer that the GCA website roster has been updated by June 1 for the determination of Club GCA dues and insurance fees for the next fiscal year.
  - 4. Attend to all Club correspondence and keep all Club stationery.
  - 5. Send a written invitation to membership and a copy of membership requirements to each elected candidate and inform the sponsors of each candidate of their candidate's invitation and acceptance.
  - 6. Notify requesting members of the approval of requested changes in membership status.
  - 7. Compose and send sympathy notes on behalf of the Club.
  - 8. Send a letter of regret to members who have resigned.
  - 9. Prepare an annual report.
  - 10. Oversee the annual Club Yearbook publication and distribution.
- F. The Treasurer shall:
  - 1. Oversee the Club Bookkeeper's financial responsibilities including managing funds, paying bills, signing checks, preparing a monthly Profit & Loss Statement and Balance Sheet detailing all fund balances.
  - 2. Collect member annual dues and income from all Club activities. Record all transactions and deposit funds in the Club's bank account. Review monthly bank statements.
  - 3. Make a financial report at Board, regular and Annual Meetings.
  - 4. Prepare a budget with the President, Vice President and Assistant Treasurer.
  - 5. Review the year-end tax returns in coordination with an accounting firm, to be signed by the President and Treasurer or as requested by the Board of Directors.
  - 6. Attend Monthly Board meetings or, if unavailable, send the Assistant Treasurer.
  - 7. Serve as a mentor to the Assistant Treasurer.
  - 8. Prepare an Annual Report.
  - 9. Participate as a member on the Grants and Contributions Committee.
  - 10. Distribute Conflict of Interest Forms to all new Board members for signature and maintain file of forms.
  - 11. Determine payment to GCA for annual dues and instruct Bookkeeper to forward payment by September 1.
  - 12. Be familiar with GCA Fiscal Policy as it concerns Insurance Coverage. Obtain Certificate of Liability Insurance from GCA Finance Assistant. Coordinate the submittal of the Insurance Activity Report to GCA with the Program Chair by September 1.

## **II. TERM OF OFFICE OF THE EXECUTIVE COMMITTEE**

- A. The term of office shall be two years.
- B. The President, Vice President, and Recording Secretary shall be elected in even-numbered years. The Treasurer and Corresponding Secretary shall be elected in odd-numbered years.

### **III. COMMITTEES OF THE BOARD OF DIRECTORS**

- A. The following standing committees shall have Chairs who are elected Directors with voting privileges:
  - 1. Awards
  - 2. Communications
  - 3. Civic Improvement & Depot Garden
  - 4. Conservation & National Affairs Legislation +
  - 5. Floral Design
  - 6. Garden History and Design & Visiting Gardens
  - 7. Historian
  - 8. Horticulture +
  - 9. Membership, Nominating & Bylaws +
  - 10. Photography
  - 11. Program
  - 12. Scholarship
- B. The following appointed committees shall have Chairs with voting privileges:
  - 1. Associate Member Liaison
  - 2. Flower Show/Symposium
  - 3. Grants and Contributions
  - 4. Ways and Means
  - 5. 100th Anniversary +
- C. An Assistant Chair shall become the Chair at the end of the term of office or as otherwise noted in the job descriptions.
- D. Chairs are encouraged to form committees in order to develop membership participation in activities.
- E. The duties of the Chair are subject to change by action of the Board of Directors.
- F. An + denotes a two-year term.
